- A \$30.00 annual enrolment fee per student will be added to the first invoice issued.
- Once enrolled fees are payable in advance, by the term. No casual class payments are accepted.
- Payments accepted via Eftpos, Direct Deposit, Cash, and Credit Card (MasterCard/Visa – 1.5% charge applies).
- Invoice payments must be received within 21 days of the date of issue. Any overdue invoices at this time will automatically be re-issued, forfeiting any discounts previously offered, a \$20 administration fee applied and class fees payable amended to the rate of \$16.00.
- Invoices will be issued prior to the commencement of each term to enable prompt payment.
- **Notification to our office, via email**, must be received prior to each new term if a student is no longer attending class/classes.
- If you experience difficulties with payment please **contact us immediately** or additional charges will apply.
- Assumption of Risk: **(Students dance at their own risk)** I recognise and agree that participation in dance and activities involving movement exercise carries with it the risk of injury.
